Penalties and Damage Price List

(valid from March 1, 2017)

In the event of breaching the conditions and terms set by the Sublease Agreement and House Rules, there are contractual penalties and a price list defined for damages caused by the Tenants/Sublessees to the equipment of the apartments and the Provider's/Lessees's property.

The Tenant is required to pay the penalty on the basis of a written notification from the Management of the Belgicka Apartments in which the reason of imposing the penalty charge will be desribed. The Tenant is obliged to settle the penalty within 5 days since receiving the email notification, either by a bank transfer or deposit to the Belgicka Apartments bank account.

Failure to settle the penalty within 5 days after receiving the notification entitles the Provider to withdraw from the Sublease Agreement. In the event of a serious breach of the House Rules, the Provider is entitled to terminate the Sublease Agreement, with no possibility of refunding the security deposit to the Tenant. The contractual penalties are set as follows:
